# 6704 PRESENTATION – CENTRE FOR LEARNING AND TEACHING

Council received a presentation from Professor Andrew Heath, Academic Director of the Centre for Learning and Teaching. The Chair thanked Professor Heath for a very informative presentation. Copies of the slides are kept with the record of the papers for the meeting.

# 6706 MATTERS ARISING

- Minute 6679 Senate discussion on refugees:
   Prof Lambert gave an update on a series of additional measures which had
   been approved by the Vice-Chancellor's Group to support students with
   refugee status, including funding provided by alumni.
- 2) Minute 6687 Student Rent increases: In response to a question, it was noted that the rent levels would be as originally proposed before the previous Council meeting, as the proposed reduction had not been accepted by the Students' Union. The Chair explained that the rents had been advertised and the accommodation was already being let to students. The saving secured from the recent tender exercise would be available to offset future rent increases beyond 2017/18 and not for other University expenditure outside the provision of student accommodation.
- 3) Minute 6694 Court minutes/Remuneration Committee: A staff member of Council read the comments made in a speech made by Lord Adonis in the House of Lords debate on the 'Public Sector Pay Cap' earlier that day. The Chair invited questions from members but there were none. Council NOTED the comment.

### 6708 ANNUAL STATEMENT ON RESEARCH INTEGRITY
