2139. MINUTES OF THE PREVIOUS MEETING

2140. MATTERS ARISING FROM THE MINUTES

(1) Minute 2119 QAA IR Library Involvement:

It was noted that the Library had been consulted over Institutional Review, and any related issues included in the Self-Assessment Document. There were no issues arising specifically regarding the Faculty.

(2) Minute 2120 NFAAR Feedback:

It was noted that an NFAAR review committee, chaired by Howard White, is in the process of being established. Feedback from both academic staff and the Students' Union will be sought in the near future.

2141. CHAIR'S BUSINESS

(1) <u>UCAS Applications</u>

The Chair reported that Faculty recruitment is showing the same number of UCAS applicants as last year, which is strong against the sector trend. The University as an institute is 7% up on the sector norm.

(2) Nancy Crawshaw Prize

It was noted that no nominations were received for the 2012 Nancy Crawshaw Prize. The prize fund will be carried over to next year.
