MINUTES OF PREVIOUS MEETING
The Board approved the minutes of the previous meeting of the Board held on 9
October 2019 (Paper 59) and there were no matters arising.
6880 CHAIR'S BUSINESS
The Chair welcomed Professor Tim Mays as the new Faculty of Engineering and Design representative on the Board, replacing Professor Chris Bowen from 2019/20. The Chair reported the following matters:

- BSc and MPhys (Hons) Physics with Theoretical Physics degrees will commence 2022/23 to align with CT (originally approved to start 2021/22).
- 2020/21 applications have increased slightly across the Faculty, but are bunched in
certain areas.
- A Memorandum of Understanding with Nankai University, China, has been approved, with associated links for the Department of Computer Science.
- NSS action plans will be reviewed and good practice shared at FLTQC (on $4^{\text {th }}$ December) and ULTQC.
- The Faculty is advertising for an Associate Dean (International). The role will include sitting on the new internationalisation board chaired by the PVC (International and Doctoral) and reviewing how the Faculty deals with international issues. The Chair clarified that there would be no teaching replacement costs associated with the post since it is not envisaged the role will involve significant travel.
- Importance of ensuring safeguarding is in place for Under 18s coming in to Departments, e.g. for work experience.
