7000 MINUTES OF PREVIOUS MEETING

The Board approved the minutes of the previous meeting of the Board held on 20 May 2020 (Paper 238), and there were no matters arising.

7001 CHAIR'S BUSINESS

The Chair reported the following matters:

• The Chair thanked Professor Frost and Mr Holley for driving through the restart of the research labs; all but a handful of labs are now back up and running. The Chair

also thanked staff for completing the documentation required to enable this.

- The Chair thanked Professor M Hejmadi for driving forward the resilient curriculum work, supported by HoDs and DoSs. A special FLTQC will take place on 22 July to approve unit and programme changes, following which communications will go out to students on what they can expect for teaching next academic year.
- University-wide VES scheme: 14 staff in the Faculty applied for the scheme across academics, technical and professional services, although the majority were from the academic community, all of which have been accepted. The Chair thanked HoDs for their work in holding discussions with staff and securing approval of the applications.
- The Chair thanked staff involved in the Call to Arms initiative led by Professor Larijani, Professor Kyprianou and Professor Davidson. A series of grants from this initiative have been submitted with more due in September.
- Recruitment is looking healthy across the Faculty. Conditional firms for Home student are up 26% compared to this time last year; Overseas up 66% (but relatively small numbers in comparison) and PGT up 75% (mainly driven by Comp Sci and Data Science, and there has also been a notable uplift in recruitment to the MSc Drug Discovery course). Applications for accommodation are also higher than they were this time last year.

7006 POSTGRADUATE TAUGHT (PGT) PROGRAMMES CURRICULUM TRANSFORMATION (CT) SCHEDULE

The Chair highlighted that the Faculty has a number of units that are used both in its undergraduate Integrated Masters courses as well as in its PGT courses. The Board therefore agreed to align PGT Curriculum Transformation (CT) with that for UG, i.e. for a 2023/24 start, as opposed to continuing with PGT CT according to the original timeframe (a 2022/23 start). Professor Fraser commented that some of the PGT courses in the Department of Computer Science require a complete refresh and the additional time to complete this would be beneficial.

7007 REPORT ON RESEARCH GRANTS

The Board received details of awards accepted by Research and Innovation Services from 13 May until 17 July 2020 (Paper 239).

The Chair congratulated in particular:

- Professor Jody Mason, Department of Biology and Biochemistry, for his award of £741,684 from Sapience Therapeutics Inc for research into the Identification and Characterisation of Library Derived PPI Inhibitors.
- Dr Tiffany Taylor (Royal Society Dorothy Hodgkin Research Fellow), Department of Biology and Biochemistry, for her award of £472,056 from the BBSRC for research into Predicting Evolution: Using Comparative Experimental Evolution to Test the Role of Mutation, Selection and Genetic Background on Repeatable Evolution.
- Dr Gernot Walko, Department of Biology and Biochemistry, for his award of £536,239 from the BBSRC for research into the Transcription Control of Human Epidermal Stemness.
- Professor Michael Whittlesey, Department of Chemistry, for his award of £427,064 from the EPSRC for research into Dual Unsaturated TM-M' Heterobimetallic Complexes for Cooperative Activation and Catalysis.
- Dr Jonathan Bartlett, Department of Mathematical Sciences, for his award of £384,872 from the MRC for research into Clinical Trial Estimands from Definition to Estimation.
- Dr Veronique Fischer, Department of Mathematical Sciences, for her award of £318,870 from The Leverhulme Trust for research into Quantum Limits for Subelliptic Operators.
- Dr James Stone (Research Fellow), Department of Physics, for his award of £316,058 from the EPSRC for research into Next Generation Endoscopes.
