7056 MINUTES OF PREVIOUS MEETING

The Board approved the minutes of the previous meeting of the Board held on 30 September 2020 (Paper 31), and there were no matters arising.

7057 CHAIR'S BUSINESS

The Chair welcomed Mr T Cheung, new Postgraduate Taught student representative (MSc Data Science).

The Chair reported the following matters:

- At the first meeting of the Faculty Employer Advisory Board last week employers reported that while graduates possessed peer-to-peer teamwork skills they were less able to adapt to teamwork in a hierarchical structure. An action plan arising from the meeting will be considered by the Faculty and will enable more detailed discussion at the next Advisory Board meeting in February 2021.
- REF: Units of Assessment (UoAs) that were either red or amber-red in the traffic light system had submitted interim documentation. Improvement was achieved as reflected in the reassessment; the Chair thanked colleagues for their efforts in developing a number of new impact case studies over the summer, and for refining existing ones. The Chair reminded HoDs of the deadline for the quasi-final documentation for the Faculty of 1 December 2020. Following submission there will be a discussion within the Faculty and with the Pro-Vice-Chancellor (Research).
- Assessment and Feedback: This has been an issue across the University, and Faculty, for a number of years. Our NSS ratings have not changed much so there is a major push at institutional and Faculty level to improve. Faculty Executive agreed the need to reduce assessment by 20% over the next few years, publish clear assessment timetables and criteria for all units, consider simplification of lab marking, make more effective use of peer-to-peer feedback and require students to reflect on, and respond to, feedback in the criteria for future assessments. Professor Hejmadi is taking these initiatives forward through FLTQC. The Chair highlighted the need for radical change in order to achieve improved student satisfaction.

Dr J White suggested that working with students from the outset to explore how they can obtain feedback from a variety of sources is likely to have a greater impact on student satisfaction than reducing assessment, which will reduce feedback opportunities, and increasing peer-to-peer feedback. The Chair explained that reducing assessment will allow feedback to be more extensive and delivered in a timely manner and will provide students with greater time to reflect on feedback before the next assessment. Student feedback on peer-to-peer feedback has been that it allows them to view feedback more objectively which in turn aids understanding.

- The Department of Biology and Biochemistry has achieved Athena Swan Silver award. The Chair thanked colleagues for their efforts in developing the documentation and action plan.
- New Research Ethics have been developed which will involve the establishment of an Ethics Board for Biomedical Sciences and Data Science.
- The increased workload of bringing teaching online has been recognised in the Workload Model, as reflected in changed tariffs.
- OfS survey of the usefulness of NSS: The Chair acknowledged that members may have made individual responses to the survey and reported the University's response which is supportive of the current format; NSS is viewed as a light-touch mechanism to collect valuable information that has guided programme design over the years. The survey closed last week and OfS findings are expected before Christmas.

Dr J White highlighted the work involved in encouraging students to engage with NSS. The Chair agreed but flagged the benefits the feedback beings to improving course delivery. The Chair explained that the University has concerns that if NSS is scrapped the OfS might introduce a more burdensome alternative.
