#### 7203 MINUTES OF PREVIOUS MEETING

The Board approved the minutes of the previous meeting of the Board held on 28 September 2021 (Paper 52), and there were no matters arising.

#### 7204 **CHAIR'S BUSINESS**

The Chair brought the following matters to the attention of the Board:

• The Chair welcomed Mr Jake Dean, new Postgraduate Taught student representative

- (MSc Machine Learning and Autonomous Systems).
- Security training: There was a recent phishing attack implicating 15% of staff, who have since been required to retake the University's information security training. The Chair reminded members that the training is mandatory for all staff. The departments that are least engaged are the academic departments; across the Faculty in some departments >80% of staff have completed the training, but in one department take up is <40%. Staff will be encouraged to complete the training across the University; a consequence of non-completion being considered is restricted access to University systems. Concerns relate to the impact on the University, e.g. data leakage, denial of access to systems and associated fines.</p>
- Curriculum Transformation (CT) update:

#### UG programmes:

The deadline for submitting Phase 2 documentation for courses launching in 2023/24 is end of November 2021 for approval by FLTQC. Phase 3 documentation for these courses will be submitted to FLTQC in Spring 2022, to be approved July 2022.

# PGT programmes:

PGT timelines are more flexible to accommodate departmental priorities. PGT courses launching in 2023/24 require approval in Spring 2022.

A CT Subgroup, an Academic Standards Working Group (ASWG) and Academic Registry are working on operational plans to support CT in the timeframe outlined above. Regulations:

<u>PGT:</u> Phased implementation for two adapted models of PGT regulations (most fruitful and risk-mitigating approach) for consideration by PGT courses launching in 2023/24.

- One-stage, with Overall Course Average only classification (regulations implemented from 2022/23).
- Two stages, with Taught Stage Average and Dissertation Stage Average classification (regulations implemented from 2024/25; exemptions from current NFAAR-PGT Appendix 11 available for courses needing to use 50% pass-mark before then).

Both models would allow course designers to designate units as condonable, or not, within the course.

Professor Hejmadi reported that a meeting had been scheduled with DoTs to discuss transition models and agree a consistent approach. The Board noted that mapping prerequisites and matching credits will be a significant task, double teaching should be avoided and plans will need to be communicated to students in due course.

### 7205 REPORT ON RESEARCH GRANTS

The Board received details of awards accepted by Research and Innovation Services from 21 September until 9 November 2021 (Paper 53).

- Professor Darren Cosker, Department of Computer Science, for his award of £3,576,195
  from Innovate UK for research associated with My World Strength in Places Fund.
- Dr Alastair Craw, Department of Mathematical Sciences, for his award of £371,292 from The Leverhulme Trust for research into Cox Rings, Moduli and Quiver Semi-Invariants.
- Dr Begona Delgado-Charro, Department of Pharmacy and Pharmacology, for her award of £319,643 from the EPSRC for research associated with Healthcare Impact Partnerships 2020-21 - Optimisation of microneedle insertion and understanding the implications of repeat application as tools to support translation.
- Dr Peter Mosley, Department of Physics, for his award of £499,997 from the Royal Academy of Engineering for a RAEng Fellowship – Euan Allen.
