Background and context

The Department of Computer Science is committed to supporting excellence in teaching. The work of the successful applicant will include contributing to the delivery of our curriculum.

Job purpose

To assist in the delivery of programmes, including the preparation of teaching material, assessment and marking of coursework. Undertake seminars, tutorials and group work, as necessary. Deliver lectures as required. Provide advice and support to students. Supervise student projects and carry out teaching-related administration commensurate with the role.

Main duties and responsibilities

The job duties and responsibilities listed below are intended to describe the general nature of the role. The duties and responsibilities, and the balance between the elements in the role, may change or vary over time depending on the specific needs at a specific point in time, or due to changing needs in the department/group. Jobholders should note that there may not be an immediate requirement to carry out all the activities listed below.

Teaching Prepare and deliver lectures, tutorials, seminars, practical classes and online learning activities – as appropriate to the department and discipline – on a defined, specific and sometimes specialist subject (undergraduate or postgraduate), with associated assessments, within an existing course framework. Includes preparing teaching materials, communicating subject matter clearly, supporting students' studies and encouraging debate to develop rational thinking as appropriate to the unit being taught. Participate in the review of undergraduate and taught postgraduate units and programmes and contribute to degree scheme review as appropriate within the Department/School.
