4	HEAD OF GOVERNANCE	
	We met with Dr Wharton, Interim head of strategic governance, 12 April.	
	We received an email from Ruth Foreman 12 April rejecting our request re participation of the University community in the recruitment of the Head of Strategic Governance, and the suggestion that a member of this working group join the recruitment panel. However, in a subsequent meeting with CoC, CoCESG and CoAA (see below) it was agreed that the candidates should be given the opportunity to hear the perspective of a representative of AA as part of the selection process.	
5.	COMMUNICATION WITH ACADEMIC ASSEMBLY	
	We submitted a report on our activities to be presented to AA on 7 May. When presenting this report we will invite suggestions from the Assembly as to how they would like us to communicate with them. SW will send one slide to AA for us to speak to in our presentation.
