PABBS evidence-based and evaluated suicide bereavement training, has been informed by a three-year study, conducted by Dr. Sharon McDonnell and her team, at the University of Manchester, funded (£243K) by the National Institute for Health Research (NIHR) and the first of its kind internationally.

Abstract

While eco-lightbulbs, tiny homes and bans on single use plastic bags nibble at the edges of our profligate ways, ecological and social sustainability is beginning to profoundly challenge long-standing conventions in end-of-life care, grieving, bodily disposal and memorialisation. This collection brings together scholarship on the different ways that all the aspects of dying, death, and memorialisation are influencing and being influenced by the global turn to ecological and social sustainability.

About the Editor - Ruth McManus is Associate Professor of Sociology at the University of Canterbury, Christchurch, New Zealand. She researches on social aspects of death and dying, and is inaugural President of the New Zealand Society for Death Studies. Her current projects include disaster memorialisation and new technologies for body disposal. Her books include *Death in a Global Age* (2012), *Death Down Under* (Cambridge Scholars 2019), and *Exploring Society* (2019).
