7605.0 Institutional update - C23/24 - 107

Minute by Gregory Noakes

Council noted the institutional update report and congratulated the University on achieving its recent triple gold in the Teaching Excellence Framework (TEF).

It was questioned if the University was doing an impact assessment for the Marking Assessment Boycott and the Pro-Vice-Chancellor (Education) confirmed that they hadn't and would consider doing this.

An update was requested on the progress that had been made with recruitment for Vice-Chancellor, Deputy Vice-Chancellor, and Head of Governance roles. It was reported that there had been a strong field of applications for the Vice-Chancellor role and the longlisting had taken place. A candidate has been identified for interim Head of Governance and the University was currently in the process of finalising this. An upcoming meeting of Senior Academic Appointments Committee would be considering the matter of the Deputy Vice-Chancellor role.

It was questioned if the University had identified any building where RAAC concrete was an issue and the Chief Operations Officer reported that one potential area had been identified and isolated while further tests were carried out.

Council noted the overall work being done to develop the estates strategy and confirmed its commitment to ensuring that health and safety concerns were prioritised going forward.

It was questioned if the University had any plans to market the recent TEF results, and the Pro-Vice-Chancellor (Education) explained that the Office of Students (OfS) had given strict guidance regarding how this information should be treated before full publication was made. It was questioned if the University had any plans to carry out a review in response to the Postgraduate Taught survey and it was confirmed that one was planned.
