This will help you to gain the essential skills needed to progress your studies or become a working social policy researcher.</p> <p>You'll enhance your understanding of the techniques used in the analysis of large-scale data and how to effectively present key insights and findings.</p> <p>This course is designed to provide high-quality training to potential doctoral students, as well as essential research skills that are desirable in a number of private and public sector roles.</p> <p>>South West Doctoral Training Partnership</p> <p>>This MRes is recognised by the Economic & Social Research Council (ESRC) (https://esrc.ukri.org), specifically, as part of the larger South West Doctoral Training Partnership (SWDTP)(https://www.swdtp.ac.uk). It can be taken as a course in its own right, or if you hold an SWDTP studentship(https://www.swdtp.ac.uk/prospective-students-and-fellows/esrc-funded-studentships/) you can take the 1+3 (MRes + PhD) pathway.</p> <p>>If you wish to be considered for a 1+3 SWDTP studentship, then you must apply for your preferred PhD route and not the stand-alone MRes. Many firms and government departments are now committed to data-driven decision-making, making use of the increased availability of big data.

This course will equip you with a hybrid skill set that combines quantitative, computing and analytical skills with an understanding of social policy research and enquiry.

This MRes also equips you to go into further study at PhD level.

Our graduates generally go on to work in a wide variety of organisations and roles, such as:

- social research in universities and research institutes, government, business, voluntary organisations and international organisations
- public policy analysis at local, national and international levels
- public information provision and campaigning within organisations concerned with wellbeing, sustainability and social justice

Contact hours

Students studying the full-time variant of this course are expected to spend approximately 35 hours per week studying, with around 8-10 of those hours being structured classes. This will be made up of a combination of lectures and seminars.

In each semester, __part-time students typically study for approximately 40%-60% of the full-time equivalent__. This usually involves taking 2 or 3 taught units per semester, alongside completing a research project that is submitted at the end of the course.
