## Course Description

<b>Course Summary</b>	Explore how we can build a sustainable global future that leaves no-one behind. Develop a broad-based social science approach with a grounding in economics.
<b>Course Description</b>	<p>On this course you'll study some of the most important challenges facing our changing world - poverty, inequality, climate change, conflict and migration.</p> <p>By focusing on policy and practice, you will explore these challenges at local, national and international levels. You'll analyse them using a multi-disciplinary approach that includes sociology and anthropology, politics and social research.</p> <p>Year 1 will develop your knowledge of economic principles and applications. You'll analyse international development and build your skills in qualitative or quantitative research. You'll also learn how to evaluate data and information to develop your own arguments for different audiences.</p> <p>In Year 2, you'll deepen your knowledge of development economics. You'll develop your understanding of the economic, social and political dimensions of diverse global and local challenges.</p> <p>In your final year, you'll do your dissertation. This will explore a global or local problem in international development through economic and multi-disciplinary analysis. You'll also study a range of optional units from within the fields of international development and economics. This will allow you to explore topics that interest you and prepare for your future career.</p>
<b>Learning and teaching</b>	<p>Informed teaching to advance your learning</p> <p>You'll learn from academics with diverse backgrounds and expertise in different areas of economics and international development. Their passion, knowledge and research activities shape their teaching with the aim of enhancing your learning experience.</p>
<b>Contact hours</b>	Contact hours

Timetabled contact hours, which may be made up of lectures, and tutorials, vary throughout your course and between courses but are typically around 10 hours a week in your first year.

Our teaching for this course is delivered through in-person learning on campus, supported by high quality online provision. A small proportion of these contact hours may be delivered online, with the significant majority taught on campus. This may be supplemented by additional activities such as a small number of online learning sessions (not live), skills development sessions, and personal tutorials.

The amount of timetabled sessions on campus in later years may vary based on the options you choose, with a greater emphasis on independent learning. Project and dissertation units will generally have fewer scheduled sessions to allow you time for your independent work - this may also mean the number of hours of timetabled sessions each week will vary within a year.

#### Independent learning

In addition to timetabled contact hours, you are expected to undertake independent learning and assessment activities. Typically, this might be around 25 to 30 hours per week in your first year, and include individual research, reading journal articles and books, working on individual and group projects, preparing coursework assignments, presentations, or revising for exams. After your first year, the emphasis on independent learning becomes greater, for example, you may do a final year project in the final year.

#### Assessment summary

You will be assessed in a range of methods designed to develop and test your skills and knowledge.

10% to 25% of your course will be assessed through examinations.

75% to 90% will be assessed through essays, reports, and presentations.

The final degree classification is determined by your second and final year marks and each contributes 32% and 68% respectively.

You will primarily be assessed as an individual, but may also be assessed as part of a group.
