#### 556 WELCOME

The Chair welcomed Mr David Stacey as the new Faculty librarian.

### 557 MINUTES OF THE PREVIOUS MEETING (FE2012-13/077)

The unreserved minutes of the meeting of the Board of Studies held on 16 January 2013 were approved with minor corrections as a correct record of the proceedings.

## 558 MATTERS ARISING

### 559 CHAIR'S BUSINESS

The Chair had no business to report.

### 561 BOARD OF EXAMINERS FOR UNITS & PROGRAMMES (FE2012-13/080)

The Board received revised details of the membership of Boards of Examiners for Units (BEUs) and Boards of Examiners for Programmes (BEPs) for postgraduate taught programmes and for franchised/licensed awards administered by the Learning Partnerships Office.

It was noted that MSc programmes in the Department of Mechanical Engineering no longer included units from the School of Management, and therefore the attendance of staff from the School of Management was no longer required. The membership list should be amended to reflect this.

### 562 SUB-COMMITTEES OF THE BOARD MEMBERSHIP(FE2012-13/081)

The Board received revised membership of the Graduate School Committee. The Secretary circulated an amended version of paper FE2012-13/081, indicating that Nello Formisano was the Student Representative (Research) on the committee rather than attending the committee.

#### 563 REPORTS FROM ASSOCIATE DEANS & DEPARTMENTS

- a) Professor Chaudhuri (<u>HoD Dept of Chemical Eng</u>) reported that Dr Pawel Plucinski had been awarded a grant of £625,000. Prize Fellow interviews were being held the following week.
- b) Dr Paine (<u>Architecture & Civil Engineering</u>) reported on two major grants awarded to colleagues in the Department, one worth 9.5m Euros and a second grant worth 1.7m Euros.
- c) Dr Darling (<u>Mechanical Engineering</u>) reported that Dr Richard Butler had been awarded a Royal Academy Chair.
- d) Professor Wright (<u>Associate Dean L&T</u>) reminded colleagues that results for students in the Faculty of Engineering and Design for Semester 1 would be going live on Friday 1 March. One Faculty had decided to make results available at an earlier date, ahead of the date given in the University's administrative calendar. This had led to a situation where students from different faculties were receiving results for the same unit at different times, and had led to some concerns from

students and questions regarding equality of treatment.

e) Professor Chaudhuri (<u>Associate Dean Research</u>) reported that preparations for the REF were ongoing. He also reported on changes to the governance of Research Centres, noting that from 2013/14 governance would move from central university administration to faculties. He observed that there would be some crossfaculty research centres. It was noted that every research centre has a lead academic and that this responsibility would continue.
