The Board received and noted the final quarter Grants & Contracts report for 2022-23. The Dean congratulated colleagues on achieving research income of £21 million compared to £14 million in 2021-22.

2297 Annual Report: Student (Graduate) Teaching Assistants 2022-23 ED2023-24/016

The Board received the Annual Report on Graduate Teaching Assistant (GTA) activity in the 2022-23 academic year. The Faculty had adopted the same reporting template used in the Faculties of Science &

H&SS and Directors of Teaching had provided their reports using the template. The critical importance of GTA input in supporting teaching was evident from the reports and the Board noted that Departments with large undergraduate cohorts were heavily reliant on GTAs to support laboratory and other teaching activities. Dr Gheduzzi commented that collation of data for the report had been informative particularly with regards to establishing a fuller picture of GTA input to assessment. The Board noted that all departments had drawn attention to the difficulty in recruiting PGR students and the risk this presented to the delivery of undergraduate teaching. The Board registered its concern that the HR frieze on casual contracts due to staff resourcing issues might also compromise core teaching.

Action: An audit to be completed of all units for which GTA input to assessment has been approved by the Board of Studies. (Secretary)
