2590 Research Activity Report ED2024-25/108

The Board received the report on Research Activity for quarter 3 ED2024-25/108 and the Chair congratulated colleagues for the positive picture of the Faculty's research application successes in the 24/25 year to date.

2591 Reports from Ex Officio members ED2024-25/109

The Board received the update reports from ex officio and academic leadership members of the Board as detailed in paper ED2024-25/109.

across the Faculty and clearer signposting to the range of spaces already provided and available, would be welcomed

2593 Library Matters

Mr Stacey provided updates on the following matters,

- 1. the normal vacation loan arrangements would be live from 23 May (with the loan period extended until 1 October).
- 2. a library 'nook space' had recently been launched providing comfy seating and a collection of 'reading for pleasure, leisure and wellbeing' books. It's called the 'Nook' to make the space a cosy "go to" destination for students and staff who need to take a break and enjoy a relaxing read. The Library Nook is located opposite the lift on Level 2 (the entrance level).
- 3. asbestos work will be undertaken in the library over the summer vacation period and subsequently in 2026 all of level 2 will be affected.
- 4. a new information librarian (Brooklyn Halliday) will be joining the team
- 5. the resources available from the University's LinkedIn Learning platform are being widely promoted. The Board queried whether it was possible to analyse student interaction and uptake of the learning opportunities available on the platform (e.g. by Dept or course).
