ACTION

1655. <u>MINUTES</u>

The Committee approved the minutes of the Faculty Learning, Teaching and Quality Committee meeting held on 2nd May 2018 (paper 92).

1656. CHAIR'S BUSINESS

Skills Centre

Miss Wood, recently appointed as Head of The Skills Centre, attended the meeting to introduce herself to the Committee and to explain some of the structural changes taking place in the Centre. The Committee noted that The Skills Centre now comprises 2 groupings: 1) Languages and 2) Academic Skills (incorporating MASH).

Miss Wood explained that The Skills Centre will be arranging focus group meetings for staff across the University so that a review of expectations and experience can be undertaken in relation to the presessional programme. Miss Wood also indicated that she would

welcome any feedback on the services and training provided by The Skills Centre currently.

The Committee noted also that The Skills Centre will be available to contribute to discussions relating to the embedding of skills in programmes as part of the curriculum transformation activity. Miss Wood invited Departments to get in touch when they are ready to discuss this.

The Committee noted that an area where academic departments would like some further input related to the training of students in appropriate referencing and the avoidance of plagiarism in coursework. Miss Wood indicated that The Skills Centre co-ordinates meetings of representatives of all areas in the University which provide skills development (e.g. Careers, Library, Doctoral College) and this provides a useful way to promote consideration of such University-wide issues/needs.

1657. <u>STUDENTS' BUSINESS</u>

Mr Hart indicated that a number of students had asked him about the curriculum transformation activity, noting that there is some confusion among some over whether there would be any impact on current students. Mr Hart re-iterated his suggestion that the best time to engage students in discussion would be in the first week of the new academic year.
