Introduction

The Music Tuition Awards contribute towards the cost of 16 weeks of University managed music lessons, spread equally over Semester 1 and 2.

These tuition awards are made possible thanks to generous gifts from Kathryn and Simon Arnold, and Sir Robert and Lady Deborah Hill who have enabled students at the University of Bath to benefit from music tuition.

Eligibility

You must be registered on any **undergraduate programme** at the University of Bath in the academic year 2023-4. This can include placement (full or part-year), remote study, part time or international students.

Previous applicants/successful Music Tuition Award recipients can apply.

Funding

The cost of two 8-week blocks of tuition is £432.

Music Tuition awardees will be provided with a discount of £280, reducing the overall cost of their tuition from £432 to £152. Awardees will need to pay up front for the two terms of tuition.

Please note: if prices of tuition rise, the discount will remain the same amount (£280).

While every effort is made to provide tuition in the instrument chosen by the awardees, this is subject to the availability of an appropriate tutor.

How and when to apply

You can apply for a Music Tuition award through the <u>online form.</u> You must have submitted your application by **23:45 (GMT) on Tuesday 3rd October 2023** to be considered.

Selection and allocation

Students will be selected upon passion for music, achievement to date and commitment to their musical progression.

Applications will be scored by a panel and successful applicants will be notified on Thursday 5th October 2023. Awardees will then need to book their lessons between 5pm that day and 5pm the next day, Friday 6th October, in order to guarantee teaching slots.

Music Tuition Awards are discretionary. This means that even if you meet all of the relevant criteria you are not guaranteed to receive an award.





Please note: Arts Scholarships and Music Tuition Awards cannot be dual awarded unless you have applied with separate artforms. If you have applied with the same artform and are successful in being awarded both, you will receive an Arts Scholarship as default.

Requirements of a Music Tuition Awardee

- Awardees must be receiving music tuition lessons through the University of Bath Student Union.
- Awardees will be expected to attend all tuition sessions: dates of which may be provided to you prior to acceptance.
- The SU Arts Team will monitor attendance. Failure to attend a session, without mitigating circumstances, may result in the award being revoked and re-awarded elsewhere.
- Scholars will be required to attend events where their benefactor (donor) or benefactor's representative may be present, including the Scholarship Reception, if it takes place in this academic year.
- Scholars will be required to write a letter of thanks to the donor, including how the funds have been used for their artistic development. They will also assist the Department of Development & Alumni Relations (DDAR, to be known as The Advancement Office from August 2023) in providing a letter of introduction (including a personalised thank you) as communication to their scholarship benefactor, within one month of receiving the award.
- Scholars are required to fill in a feedback form at the end of the scholarship year.
- All reports and feedback requests must be completed and returned by the appropriate deadline, and all correspondence responded to in a timely manner to meet with the terms of the award, and for the awardee to be considered for future scholarships/awards.

Publicity

• Your name, the name of your scholarship, and excerpts from your application, survey responses, any reports or letters you provide for your donor may be used in online and print materials to promote and publicise the impact of our philanthropic scholarships. We will contact you before we use any material that could identify you as an individual.

Suspension, withdrawal from studies or study deferral

If you suspend, defer or withdraw from your studies whilst in receipt of a Music Tuition Award, you will not be eligible to receive further tuition that academic year. In these circumstances you will receive a refund from the SU for the remaining unused lessons. You must notify the Arts Scholarship team on arts-scholarships@bath.ac.uk if your circumstances change.

If you defer or withdraw and restart, any award already offered will become void.

General Terms and Conditions

Music Tuition Awards are allocated for 2023/4 entry only.

By accepting an award, you are agreeing to the Department of Development & Alumni Relations / The Advancement Office to share information about you from your Music Tuition application form with the Donor(s) who funded your Scholarship.

Should any of these Terms and Conditions **not** be met, the University reserves the right to withdraw the Scholarship at any point within the academic year.
