402 Review of CILOs for MSc courses with placements

The members of the Board considered a report reviewing the CILOs for School's MSc courses with regard to difference between courses with and without placements (Paper SM24/25-084).

The Director of Teaching for Postgraduate Taught Courses noted that he had reviewed current Course Intended Learning Outcomes (CILOs) for courses that had placements and compared these to courses without. Overall there is a mix of practice with some courses attaching unique learning outcomes to different elements. However, from first running of the courses there is confidence that students achieve all the course learning outcomes taking any of the summer units offered to them.

The Board noted that one course does not link any CILOs to the summer units, this is MSc Entrepreneurship and Management. This appears to be an oversight and should be corrected.

The Board considers it to be a useful exercise to investigate whether there would be value in differentiating CILOs based on whether students undertake a dissertation/project or if they undertake an internship.

It was noted that CILOs are material information and so changes need to be implemented for future applicants only.

AGREED: Confirm MSc Entrepreneurship and Management CILOs that relate to summer units.

AGREED: Consult with Directors of Studies for School's MSc courses to establish if there is value in making the contribution made to CILOs by different project units (e.g. Dissertation, Practice Track or Internship) more distinctive.

403 Annual report on appeal review requests

The Board considered report on appeal review requests received within the School during 2023/24 session (Paper SM24/25 – 085).

The Board noted the continued (year on year) increase in the number of appeals submitted. Conversations with colleagues suggest similar increases were occurring across the Faculties. As the majority of appeals are based on the grounds of late IMCs, the Secretary noted that the University is currently reviewing the IMC process. It is hoped that a move toward providing greater support for students whilst they are studying will remove the need to seek 'remedial actions' at the end of their study.

The Board discussed potential reasons for the increases. Noting that the School had trialled some elements of the PGTAR for the University, and that this had resulted in a number of the postgraduate taught appeal submissions. More generally, a view was expressed that students are more aware of the IMC process and also learn from previous cohorts that there may be advantages to submitting appeal requests.

AGREED: The Board will monitor the increase in appeal submissions, seeking to understand if volumes reduce as the PGTAR are embedded.
