464 Academic prizes – review of undergraduate prizes

The Board discussed a proposal to withdraw funded academic prizes from undergraduate courses (Paper SM24/25-158).

The School currently has a series of sponsored academic prizes however companies have become less interested in providing this type of support. The proposal is to withdraw the current sponsored monetary prizes replacing with a "Dean's Award" certificate that will be presented to the student with the highest course average in each course of study. When more than one student achieves the same top course average they will each be awarded the certificate.

The Board was informed that discussions with students had noted they were more interested in having the recognition to note on their curriculum vitae than in receiving the money that had been associated with the current sponsored prizes.

AGREED: The Board agreed to the withdrawal of sponsored prizes for the School's undergraduate courses and the establishment of the Dean's Award.
