Introductory items

15143 - Welcome and Quorum

The Chair welcomed members and attendees and made a formal note of attendance to ensure that quorum was maintained throughout the meeting.

15144 - Declarations of Interest

The Director of Education and Student Services, who was in attendance at the invitation of the Chair, declared an interest in item 15158. It was agreed that they would leave the meeting for this item.

15145 - Minutes of the Previous Meeting – S21/22 – 87

The open minutes of the previous meeting of Senate held on 6 April 2022 were approved.

15146 - Actions and Matters Arising – S21/22 – 88

Senate noted the action log.

The Pro-Vice-Chancellor (Education) provided Senate with updates on the following actions:

1. Updated Terms of Reference for the Education Board and EQSC (minute 15046)

Senate had previously approved Terms of Reference for the Education Board (minute 15046). It had been agreed that the Terms of Reference for the Education Board and EQSC would require updating as the flow of business became more apparent. The Terms of Reference had not yet been finalised, but a joint meeting would be taking place in September, after which the EQSC Terms of Reference they would be brought to Senate for approval and the Education Board Terms of Reference for context.

2. Costs of Inspira (minute 15112)

The University was currently spending €130,000 per annum (equivalent to €6,50 per student).

The Pro-Vice-Chancellor (Education) addressed Senate on a matter arising in relation to examination uploads. After the semester 1 assessments there had been a number of late submissions from students uploading online assessments. Following this, the late submission process was changed and students were informed that a fixed amount of time would be allowed after examinations to upload assessments.

At the end of semester 2 there had been further late submissions. There was some evidence to suggest that some of these were due to genuine technical reasons, for example, a lack of internet service in some areas over the submissions deadline. EQSC, the SU and the Deans had agreed that it would be appropriate to extend the individual mitigating circumstances (IMC) deadline by a week to allow the late submissions panel to consider *bona fide* cases where there had been technical difficulties in uploading assessments. They therefore sought Senate's approval to delegate the power to the Pro-Vice-Chancellor (Education) to temporarily suspend Regulation 15.

The following points were raised in discussion:

- The SU thanked Academic Registry for the speed of its response to the issue.
- The IMC deadline for students with any non-technical reason for late submissions was 8 June. If evidence of a technical issue existed at the time, it should already have been presented to the panel. Academic Registry was working on guidance for the IMC panels.
- Academic Registry would provide a list of relevant students to the panels and would also be writing to all students with a rejected submission.
- 40% of late submissions came from first year students: there were plans in place to look at how to minimise this going forwards.

Senate <u>approved</u> the delegation of authority to the Pro-Vice-Chancellor (Education) to make the necessary changes to temporarily suspend Regulation 15 for this year for the affected group of students.

Part I: Items in this part of the agenda are for discussion

15147 - Institutional update - \$21/22 - 89

The Vice-Chancellor presented the institutional update and thanked colleagues at the University and The SU for their work over the year.

The Vice-Chancellor stated with great regret that Police Scotland had found a body which was believed to be that of missing PG student Bilin Chen. He thanked Student Services, Security, and the teaching staff who had been involved in the case. The University had also been in contact to express sincere condolences with Bilin's family, who had expressed their sincere thanks.

The Vice-Chancellor informed Senate that there had been a fire that morning in the kitchen of a flat in Polden. Fortunately, University staff and emergency services responded quickly and there were no injuries.

The University was ranked 179 in the recent QS rankings. Time would be spent considering this in detail over the coming months as the University was keen to maintain its international profile. He congratulated Dr Ruth Webster who had recently won the Royal Society of Chemistry's 2022 Dalton Division early career award: Sir Edward Frankland Fellowship. The Pro-Vice-Chancellor (Research) congratulated all colleagues who had won significant grants and prizes.

The Pro-Vice-Chancellor (Education) informed Senate that Ofsted had performed an unannounced visit in May in relation to the degree apprenticeship programmes. The University was still awaiting the final report, but the initial findings suggested that Ofsted would like to see more understanding between university governance and degree apprenticeships: accordingly, in due course, reports would be brought to Senate.

The University was also preparing for the TEF submission, which would be likely to take place in early 2023.

15148 - Research Excellence Framework (REF) – S21/22 – 90

The Pro-Vice-Chancellor (Research) presented paper S21/22 – 90 on the REF results. The following points were noted:

- Many more colleagues had been submitted compared with the 2014 REF (763 compared with 462).
- The University's GPA had increased from 2014.
- 92% of research was classed as world-leading (compared with 82% in 2014).
- Comparisons between 2014 and 2021 had to be taken with caution as there was a significant change in submissions.
- Overall, there were some very pleasing results for the University but also challenges in some areas.
- There was a need to focus on 4* research impacts and outputs if the University wanted to improve its ranking.
- The Pro-Vice-Chancellor (Research) would be speaking with departments about targets for the next REF.

15149 - Framework for Research Entities - S21/22 - 91

The Pro-Vice-Chancellor (Research) presented paper S21/22 – 91, which set out a proposed framework for Research Institutes, Beacons, Centres and Groups, with associated changes to Ordinances.

The following points were raised in discussion:

- The Framework aimed to articulate the difference between the various research entities, and to use these going forwards to drive an improvement in the University's research presence, to build an inclusive research culture, and to appropriately fund research.
- Ordinances were not 'permissive' and removing Ordinance 4 would not prevent departments from structuring themselves in any particular way.
- It was important that the University was tagged in research to improve citations. Consistency was also important, and the Framework was designed to help this.
- It was suggested that the policy should state that the 'appropriate department' should be referenced in any research, rather than the 'home department'.
- Minor typographical errors were noted for correction.

Senate <u>approved</u> the adoption of the Framework for Research Institutes/Beacons/Centres and Groups, subject to some amendments to wording, and <u>agreed to recommend to Council</u> the removal of Ordinance 4.

15150 - Statement on Research Integrity - S21/22 - 92

The Pro-Vice-Chancellor (Research) presented paper S21/22 – 92 which set out the University's Statement on Research Integrity. There were no comments or questions.

Senate <u>agreed to recommend to Council</u> the Statement on Research Integrity.

15151 - Sabbaticals - S21/22 - 93

The Pro-Vice-Chancellor (Research) presented paper S21/22 - 93. This proposed a number of changes to Ordinances concerning sabbaticals, most notably allowing staff on sabbatical to receive up to 100% of their normal salary.

In response to questions, it was confirmed that the sabbatical scheme would eventually be expanded to included teaching, as well as research, colleagues.

Senate <u>agreed to recommend to Council</u> amendments to Ordinances in relation to sabbaticals.

15152 - Curriculum Transformation – S21/22 – 94 (A and B)

The Pro-Vice-Chancellor (Education) gave an update on Curriculum Transformation. The following points were raised in discussion:

- Discussions were taking place with the group looking at the workload allocation model, but resourcing would likely be a local issue that the HoDs would need to address
- A pre-delivery checklist was being developed in consultation with HoDs to support departments.

The Director of Academic Registry and Dr Laughton presented paper S21/22 – 94B which set out:

- The full text of PGT Assessment Regulations version 22-23.1 for use in academic year 2022/23 by CT courses in the Faculty of Engineering & Design.
- Specifications for generic Postgraduate exit awards.

- The direction of intended further work to take place across summer / autumn 2022 on undergraduate assessment regulations for 2023/24 and for a subsequent version of postgraduate taught assessment regulations for 2023/24.
- A proposal that authority be delegated to the Chair of EQSC to approve work undertaken by the Director of Academic Registry across summer 2022 to implement regulation change to NFA-PGT, NFA-UG, and IMCA documentation related to the implementation of agreed assessment regulations changes.

The following point were raised in discussion:

- The assessment regulations were much shorter and framed around six core rules.
- The 50% pass mark brought the University in line with the sector.
- Senate members welcomed the proposal to be able to grant postgraduate exit awards to those students who left before completing their dissertation.

Senate <u>approved</u>:

- The PGT Assessment Regulations version 22-23.1 for use in academic year 2022/23 by CT courses in the Faculty of Engineering & Design.
- Specifications for generic Postgraduate exit awards.
- The direction of intended further work to take place across summer / autumn 2022 on undergraduate assessment regulations for 2023/24 and for a subsequent version of postgraduate taught assessment regulations for 2023/24.
- The delegation of authority to the Chair of EQSC to approve work undertaken by the Director of Academic Registry across summer 2022 to implement regulation change to NFA-PGT, NFA-UG, and IMCA documentation related to the implementation of agreed assessment regulations changes.

15153 - Assessment - S21/22 - 95 (A and B)

The Pro-Vice-Chancellor (Education) presented papers S21/22 – 95A and 95B which set out the six action points for assessment and feedback, to be delivered in the academic year 2022/23 as a transitional year to academic year 2023/24 and beyond. This built upon discussions which had previously taken place at Senate regarding assessments (minute 15097).

The following points were raised in discussion:

- It was important to remember that students would have a very different experience of assessments from the staff that set them. There was a need to ensure that students were not put under too much pressure when the process was redesigned.
- The School of Management offered to be involved in the pilot project for in-person invigilated exams.

Senate <u>noted</u> the six action points for assessment and feedback and <u>noted</u> that EQSC would consider the direction of travel to simplify arrangements for the delivery of summative examinations in support of agreed guiding principles. Senate <u>approved</u> the disposition of revision and assessment days for the 2022/23 academic year chart.

15154 - Degree outcomes - S21/22 - 96

Senate <u>noted</u> the update to the PGT outcomes paper, which had previously been considered at Senate on 6 April 2022.

15155 - Courses of study - S21/22 - 97

The Pro-Vice-Chancellor (Education) and the Director of Academic Registry presented paper S21/22 – 97 which outlined a proposed strategy for course approval and amendment processes post-Curriculum Transformation and sought approval for the relevant changes necessary to implement the first phase of this approach in 2022/23.

The following points were raised in discussion:

- The return to light touch annual monitoring was welcomed.
- There had been external input throughout the process.
- There was further work to be done in terms of reinstating a programme of review.

Senate approved, with effect from 1 August 2022:

- the merger of Curriculum Transformation Committee (CTC) functions into Courses and Partnerships Approval Committee (CPAC), including relevant revisions to CPAC and S/FLTQC Terms of Reference;
- the adoption of the draft *Academic Framework (10 Credits)* for use with all new and transformed courses;
- the retention of the current academic framework under the new title *Academic Framework (6 Credits)* for continued use with pre-transformed courses;
- revisions to University of Bath award titles and levels of credit within the Framework for Higher Education Qualifications (FHEQ);
- revisions, including title change, to QA3 Approval of New Courses of Study;
- revisions, including title change, to *QA4 Amendments to Courses of Study and Units and Approval of New Units.*

15156 - Student complaints and dignity and respect – S21/22 – 98

The Pro-Vice-Chancellor (Student Experience) presented paper S21/22 – 98, which set out revised policies in respect of the Student Complaints procedure, the Dignity and Respect policy and the Dignity and Respect procedure. The Pro-Vice-Chancellor (Student Experience) explained that there had been engagement with a wide range of stakeholders and the proposed changes aimed to address potential or perceived conflicts of interest, long investigation processes, a perceived lack of support, and concerns from staff that investigations were stacked in favour of students.

In response to questions, it was confirmed that the University could not prevent students from appointing lawyers, but that under the procedures any such lawyer would only be able to be present in a support capacity and would not be allowed to represent the student or speak on their behalf.

Senate <u>approved</u> the Student Complaints procedure and the proposed amendments to Student Regulation 7 and Student Regulation 8.

Senate agreed to recommend to Council the Dignity and Respect Policy and Procedure.

15157 - Regulations for 2022/23 - S21/22 - 99

The Head of Governance introduced paper S21/22 – 99 which set out the proposed Regulations for the 2022/23 academic year. They explained that next year the Regulations would be shared in advance so that Senate could engage in a full and thorough review.

In response to questions, it was noted that an amendment to the Regulations could be brought back to Senate next year if the University wished to change its position on the use of e-scooters on campus.

Senate <u>approved</u> the Regulations for the 2022/23 academic year.

Senate noted that a full review of the Regulations would take place in 2022/23.

Senate <u>approved</u> the delegation of authority to the Pro-Vice-Chancellor (Education) to approve amendments to the Regulations for Student Apprentices in time for the start of the 2022/23 academic year.

15158 - Senate matters - S21/22 - 100 (A - C and combined appendix)

The Director of Education and Student Services left the meeting.

The Head of Governance introduced paper S21/22 – 100A. There were no comments or questions. Senate:

- Approved the proposal to remove the provisions for the co-option of members to Senate and to replace them with provisions to allow regular attendance;
- Approved the regular attendance of the Director of Education and Student Services at Senate;
- <u>Approved</u> the proposal to remove provisions in relation to casual vacancies and to replace them with vacancies for full terms;
- Approved the proposal for handling a likely period of parental leave required by a member of Senate and <u>noted</u> the intention to bring forward a Senate parental leave policy in the 2022/23 academic year;
- <u>Noted</u> that proposals would be brought forward in 2022/23 to rationalise the mechanisms for Senate to appoint its members to committees, executive bodies and statutory bodies of the University;
- <u>Approved</u> the proposal to simplify the election mechanism by which members of Senate were appointed to Council;
- <u>Approved</u> the proposal to fix the term of Senate members of Council at three years, irrespective of the duration of the remainder of their term on Senate;
- Approved the amendments to the Standing Orders; and
- Agreed to recommend to Council the amendments necessary to implement these changes, with an effective date of 1 August 2022.

The Director of Education and Student Services rejoined the meeting.

The Head of Governance introduced paper S21/22 – 100B. There were no comments or questions. Senate <u>noted</u> Council's appointment of external facilitators to conduct an effectiveness review, and the possible involvement of Senate members in that review. Senate <u>noted</u> an update on Council proposals to reduce itself in size.

The Head of Governance introduced paper S21/22 – 100C. There were no comments or questions. Senate <u>approved</u> the amendments to Senate's Standing Orders.
