## **15394.0 Minutes of the Previous Meeting - S22/23 - 37**

## **15396.0 Institutional update - S23/24 - 38**

The Vice Chancellor thanked staff members for the successful completion of Semester recognising that a huge amount of work was delivered. He also thanked everyone for the hard work that went into exams.

It was noted that Universities and their activities around pathway foundation years are being discussed in the media, particularly the Sunday Times, however after looking into this again Senate were assured that such practices do not happen at the University of Bath.

The Vice-Chancellor paid tribute to the University Community, with particular thanks to its international student community. As it was an election year it was the case that universities were facing criticism from all sides. While universities may be criticised, student communities should not be treated like commodities.

The Vice Chancellor noted that it was a privilege to meet student leaders and see the

impressive activities happening outside of academia. International students are important to the University community their contributions to our community are as important as ever. Personal thanks was also extended to the staff and SU for their engagement with students, which had allowed the University to avoid some of the issues that had been seen in the media.

The Pro-Vice-Chancellor (Student Experience) highlighted that the policy review of Student Complaints, Student Discipline, and Fitness to Study has undergone changes and will go live at the start of the semester.

It was noted that the Be Well survey took place in November 2023 and a dashboard had been launched which would enable the University to identify the appropriate data to pass on to colleagues in future years, both to academic and professional services to enable us to act on the comments received.

The University was notified by Student Minds that it had achieved the University Mental Health Charter. This was an ongoing award subject to certain conditions being met. It was emphasised that the University was aiming to achieve these conditions by the summer and would report back to Senate on progress.

The Pro-Vice-Chancellor (Education and Global) gave an update on the University's Access and Participation Plan (APP), which was approved by the Office for Students (OfS) in October 2023. Within the approval letter from the OfS the University was invited to reconsider its access targets. Since then the Vice-Chancellor, the Head of Widening Participation, and colleagues in the Widening Participation team had been having conversations with the Director for Fair Access and Participation at the OfS and a paper had been submitted that amended the University's access targets for free school meal receivers and AP1 and 2 targets. These would stay at the same level for the first few years and then increase. An extensive narrative had been produced, which focused on how these targets were appropriate and how to build on them. This had been approved by UEB and recommended to Council for sign off. This update would then return to Senate. It was emphasised that UEB and other stakeholders were supportive, and that we had done what was considered appropriate for the University and would continue discussions with the OfS.

The Pro-Vice-Chancellor (Research & Enterprise) paid testament to the hard work of colleagues that had seen the total value of the University's research portfolio increase to the highest it had ever been at £185 million.

Engagement with Centres for Doctoral Training was positive, with the Centre of Excellence in Water-Based Early-Warning Systems for Health Protection being awarded £8.4 million from Research England.

It was noted that the University's spin-out companies were performing well, particularly the Clean Food Group and Ensilitech.

Two colleagues who had received UK Research and Innovation Future Leaders Fellowships were congratulated; and Research and Innovation Services (RIS) were also thanked for their support.

It was noted that preparation for REF2029 was underway, with a consultation soon to begin on research culture to which all colleagues were invited to contribute.

A question was raised on point 10 of the report around the profile of the international academic community, and it was confirmed that this was an area of concern for the University, but that HR were working hard on the new technical detail that had emerged. It was suggested that there may be clauses that would allow special cases through, which would make the transition easier, however this had not yet been communicated to the sector.

## 15397.0 Semester One Review - S23/24 - 39

Senate noted the Semester One Review update, with particular reference to the smooth and successful launch of Year 1 of the Curriculum Transformation courses. Senate also noted the student experience data which showed that students had been active in many different areas, including sports and other activities. The University Librarian confirmed that they had some valuable data which could be added to this report in the future.

Senate members sought assurance that plans were in place to prevent the reoccurrence of the recent issue with the Economics exam paper which had included the answers leading to a whole cohort of students needing to resit their exam. The Pro-Vice-Chancellor (Education and Global) confirmed that a full investigation was still underway, but that plans had been made to rectify the situation. 3/4 of the 400 students re-took the exam on Friday 26 January, with the remaining 1/4 of students planning to re-taking on a second planned date in early February. Communications between the department, students and Academic Registry had been managed well. Assurance was also given that action would be taken to mitigate against bias between students taking the first and second resit examination.

## 15398.0 Presentation - Lifelong Learning Entitlement, Freedom of Speech

### *Lifelong Learning Entitlement*

The Chief Compliance officer gave a presentation on the Lifelong Learning Entitlement ("LLE") and the Higher Education (Freedom of Speech) Act 2023.

Senate were told that the LLE had received royal assent in September 2023 and established a lifelong learning entitlement pot which would provide four years of full-time funding tuition fees at level 4-6. This would become available for academic year 2025/2026 and at a modular level from 2028.

There would be a move from association of the payment of tuition fees from "years" of study to the payment being associated with credits. All of the government documentation regarding credits is based on the CAT system of 120 credits per academic year. The University is uniquely challenged as it uses the ECTS system of 60 credits per year. This would have an impact on the promotional materials that the University publishes as there would be a need for an explanation as to why 60 credits were being awarded and how they compared to the credits award on the CAT system.

Each course would have a credit cap and there would be a nationally standardised transcript. It was not yet clear how a repeated year would be recorded on the transcript. For five-year undergraduate masters courses additional credits would be required which could put the University at risk of loss of income.

There were potentially going to be implications for placement income and placement study abroad. Where there were "thin" sandwich courses the students may not be away on placement long enough to receive credits for such courses.

It has been indicated that higher education providers would need to invest c£100k in systems development to respond to the LLE. It is suspected that in the University's case this figure may be higher due to it using a different credit system and the need to convert these into ECTS credits for the purpose of recording on the national transcript.

Senate asked what impact the scheme would have on students who stepped out of higher education during their courses. The Head of Compliance said that they would still have a national transcript of the credits that they had accrued so far and would still have the remaining credits to potentially use in the future.

It was asked as to why the university doesn't switch to the ECTS credit system. The PVC (Education & Global) said that the time to have done that would have been when CT was introduced and before the courses were rolled out. He said that there should be a move in the future but at the start of the CT roll out was not ideal. The Director of Academic Registry said that there were not sufficient resources at the time of the CT introduction for the switch to take place but that this would need to be addressed in the future.

### ***Freedom of Speech***

The Chief Compliance Officer gave an overview of the Higher Education (Freedom of Speech) Act 2023. This replaced the duties as they related to free speech under section 43 of the Education Act 1986. A key requirement of the new legislation was that universities now had a duty to "promote" freedom of speech. This requirement would become part of the OfS condition of registration.

University would be required to publish a code of practice before August 2024. There would also be requirement on Students Unions to publish their own codes of practice and they would also be monitored by the OfS.

The OfS would be developing a complaints scheme and they had already appointed a new Director of Free Speech. There would also be a prohibition of non-disclosure agreements being used in cases of sexual harassment and sexual misconduct.

The Director of Compliance said that the University required a new code of practice to be drafted. There was mention of academic freedom in the University's statutes and a statement on academic freedom had been developed by the Academic Assembly in 1988. There was a need to more fully articulate the University's values as they related to Freedom of Speech and have them set out in one document. A task and finish group had been established and the draft Code of Practice would be coming to Senate for their consideration before final approval was given by Council.

Senate noted the presentation on the LLE and Freedom of Speech.

## **15399.0 Degree Outcomes - S23/24 - 40**

Purpose - For Noting

The Pro-Vice-Chancellor (Education and Global) presented the report. It was noted that a more detailed analysis of the degree outcomes for 2022/23 would be brought back to Senate later in the academic year and the granular trends can be discussed then.

Regarding a comment that degree outcomes are returning to pre-pandemic levels, it was asked whether the University could expect to see student performance surpass these levels, especially given the changes brought by the Curriculum Transformation project. It was noted that assurance should primarily be sought on whether the University is setting its assessments at the right level and properly supporting students to take those assessments. Ideally, the University would then try to keep the number of students achieving upper awards maintained within a broad level. It can be observed, however, that one department which has already launched its Curriculum Transformation courses has seen an increase in the number of upper awards achieved. It is likely to be a few years before the overall impact of the Curriculum Transformation changes can be seen.

## **15400.0 REF 2029 Rules and Framework - S23/24 - 41**

Purpose - For Discussion

---

It was noted that more information had been published on the next REF exercise. A preliminary decision had been made, and it was now confirmed to be REF2029 due to the addition of a new element People, Culture, and Environment (PCE).

It was noted that the University had put itself forward to take part in the pilot as this offered the opportunity to receive more feedback. Participants in the pilot would be chosen from across the sector, not just the Russell Group.

It was noted that contribution to understanding will be weighted at 50%, which is a significant part of REF, and it is therefore important to continue focussing on this. RKEC had indicated that it would be important to look at quality not quantity, and that being rigorous would help.

The new rules put no minimum or maximum limit on the number of outputs attributed to individuals, demonstrating a move away from individuals and towards institutions. This however required department-wide outputs to achieve high PCE scores. It was noted that colleagues who had a substantial link with the University could be counted but PhD theses and outputs from colleagues without research elements to their contracts would not be counted.

The University was still modelling what best outcomes in Units of Assessment might be, but it was evaluated that this would be overall the same as REF2021.

The number of impact case studies the University was required to submit had been reduced, and the 2\* evidence to underpin it was therefore not required. It was noted that the University would still consider 2\* output due to potential slowness to change in those assessing REF.

It was noted that the rules would continue to update as REF got closer due to ongoing consultations and the resulting evolution of the rules. It was considered that the University was in a positive place, but that its ambition was to hit the top ten, which would be challenging and need us to be well-organised and prepared. It was considered positive that our research award income is tracking upwards, and every effort should be made to keep this increasing.

All colleagues who were taking a lead role in reviewing outputs were thanked, as this was helping to build a picture of the institution and identify any gaps. Those who responded to the email on the consultation of the six pillars on PCE were also thanked.

The Vice-Chancellor also thanked all those involved and recognised that a huge amount of work had already been done. Departments were also urged to consider 4\* output, especially if they had already achieved all the 3\* output necessary.
