The tables of international student numbers shows students whose domicile is other than UK and whose nationality is other than British. This analysis assumes that the students from the Channel Islands and the Isle of Man and any student whose nationality is not known are not international students. The table includes all types of active registrations: core, visiting students and staff registrations. Domicile is the country of the student's permanent or home address immediately preceding the start of their programme of study.

13% of international students (based on nationality) are based off campus, of which 41% are on distance learning programmes*.
