**IN-YEAR UPDATES TO THE QUALITY ASSURANCE CODE OF PRACTICE
& RULE 2 – CONDUCT OF EXAMINATIONS**

Dear Colleagues

1. A number of revisions to the [Quality Assurance Code of Practice](#) (QA CoP), have been approved by the Chair of the Education, Quality and Standards Committee (EQSC) for immediate implementation. The online version of the QA CoP is the primary source, and any previous paper or electronic copies held should be deleted or marked as obsolete.
2. In addition, [Rule 2 – Conduct of Examinations](#) has been updated to reflect the move to online examinations. Changes to Rule 2 are agreed by the Director of Academic Registry in consultation with the Chair of Boards of Studies and appropriate Professional Services.
3. Several factors have contributed to these amendments:
 - The implementation of a series of ‘no-detriment’ measures for the 2020/21 academic year.
 - The move to online exams for 2020/21, using Inspira.
 - The conclusion of the emergency measures implemented for assessments and Boards of Examiners during Semester 2 and the supplementary period, 2019/20. From 2020/21, the main QA CoP applies.

QA28 Conduct of Examinations	With the move to online examinations, this statement has been suspended for semester 2 and the supplementary assessment period, 2020/21. Please instead refer to Rule 2 – Conduct of Examinations .
QA48 Student Engagement with Quality Assurance and Enhancement	1.8 reference to QA16 updated to align with latest updates.
QA53 Examination and Assessment Offences	Updated to provide additional clarity in relation to the handling of suspected assessment offences that involve more than one student (i.e., collusion), and that a ‘viva voce’ may be utilised as part of investigation of an alleged offence.
