### 99. MEMBERSHIP AND TERMS OF REFERENCE

As the PVCID and PVCR will have additional duties prior to the new VC starting, the Chair proposed that the ADDR should be added as an additional Vice Chair. The Committee agreed with this proposal.

Following a request from Lizzie Hope, Pre Award Manager (PAM) in RIS, to attend the meeting in place of Alison Evans, the Committee discussed whether her membership of the committee should be formalised. It was agreed that RIS should be represented on the committee and Lizzie will be invited to be in attendance at future meetings.

The Doctoral College's Annual Review document made some recommendations concerning the membership of UDSC. These related to the attendance of the ADRs and the F/SDDSs at both UDSC and BoSD, and the perceived need for greater student representation on UDSC. After some discussion the Committee agreed that they did not want to change the fact that ADRs and F/SDDSs attend both UDSC and BoSD meetings, however they were strongly in support of inviting student Chairs of Faculty/School-level PGR SSLCs, or faculty reps, to be full members of UDSC, as it was felt that this would increase opportunities for the doctoral student voice to be heard at University level as well as aid the dissemination of information. It was agreed that the HDDSE would contact the Chairs/reps about this, once they have been appointed.
