The meeting started with a minute's silence for Roger Pedder, who passed away on 1st October. He had been a member of Council from 2003 until 2007 and also Treasurer from January 2008 until December 2010.

The Chair welcomed Mrs Christine Gibbons and Mr Sam Sharpe to their first meeting as newly appointed members. Dr Aki Salo was welcomed as the new Chair of Academic Assembly and Professor James Davenport as new member elected by Senate.

6435 PRESENTATION

Council received a presentation from the Students' Union (SU) on their Top 10 Issues for 2015/16. The Chair thanked all the presenters for a very informative and interesting presentation. The slides are kept with the record of the papers for the meeting. There was a discussion about the development of the Dignity and Respect policy, following on from one of the previous year's Top Ten issues.

It was agreed that the SU would report back to Council on progress towards the end of the academic year.

Council noted its membership and functions (Paper C15/16 – 01).

6437 MINUTES OF PREVIOUS MEETING

6438 MATTERS ARISING

Minute 6428: Manvers Street, approval of Additional Funds. Martyn Whalley reported that the design was progressing well; a final cost was not yet available but it would not exceed the amount approved by Council.

6439 REPORT OF THE VICE-CHANCELLOR

Council NOTED the report of the Vice-Chancellor (Paper C15/16-03) on key issues for the University. The Vice-Chancellor also reported on the recent University's top ten ranking in the THE 'Table of Tables'.

It was also noted that UCU were no longer in dispute over the staff pay offer; 1% would be paid in November, backdated to August 2015.

6440 ANNUAL REPORT FROM THE ACTING DIRECTOR OF HUMAN RESOURCES 2014/15

Council NOTED the Annual Report from the Acting Director of Human Resources 2014/15 (Paper C15/16-07). Peter Eley attended for this item.

There was a discussion about the increase in staffing levels, staff development, sickness rates and the low percentage of female professors. It was NOTED that in Appendix 9, item 7, 110 was 81% of 135 (not 90%). It was also NOTED that although the University had agreed to pay a supplement to bring staff pay up to the level of the Living Wage, it did not feel it was appropriate to guarantee this contractually as the rate was not within the control of the University.

6441 <u>UNIVERSITY STRATEGY FRAMEWORK</u>

Council considered Paper C15/16-10, and APPROVED the amendments to the Framework for the Maintenance of the University Strategy and the indicative timetable for the development of the new University Strategy.

6442 50th ANNIVERSARY

Council NOTED Paper C15/16-09 regarding preparations for the University's 50th Anniversary.
