Minute by Gregory Noakes

The following minute was taken from the discussion held at the Senate Development Session.

The Pro-Vice-Chancellor (Education) thanked colleagues across the University for all the work they had done in advance of the launch of the Curriculum Transformation. Its implementation was being monitored to identify anything that might need to be improved.

The Pro-Vice-Chancellor (Education) presented three papers on Marking and Assessment Boycott that Senate would be asked to formally approve at its formal meeting following this development session. They explained that at this point they were seeking views, comments, and questions on the papers.

The Director of Academic Registry noted that previous feedback from external examiners had been very complimentary of the previous MAB policy. It was highlighted that the University's reputation is heavily dependent upon the quality and standards of its degrees. The proposed approach will ensure that degrees will retain their integrity.

It was questioned whether staff union members would be required to declare a conflict of interest on this matter as previously done at the last meeting. The Vice-Chancellor explained that it would not be required as Senate were not being asked to formally vote on this.

Clarification was sought on one of the abbreviations used within S2324 - 03 - Paper 2 appendix 2 and it was agreed that this would be checked.

It was questioned if under this proposal external examiners would still be expected to carry out their normal tasks of moderation and the Director of Academic Registry assured Senate that they would. The intention of the proposal was to build reasonable flexibility into the system to enable it to adapt better to potential disruptions.

It was questioned to what extent were regular disruptions to marking and assessments becoming the new 'norm' for the University given the various types of disruptions experienced over the past five years. The Pro-Vice-Chancellor (Education) explained that over the next year they hoped to look at having contingency plans put in place for such disruptions that the University could fall back on when the need arose.

It was suggested and agreed that the Research Advisory Board would benefit from having a student member on it as the Terms of Reference refers to dealing with student issues.
