News from CDAS

CDAS Conference 2016, 'Survival' open for booking

18-19 June 2016 Chancellors' Building, University of Bath

Survival can be among the very best, or the very worst, of human experiences.

It can mean: surviving disaster, accident, illness, HIV, war, genocide, rape, domestic or child abuse, or loss of any kind. It can lead to survivor guilt, post-traumatic stress, 'surviving' yet life no longer feels worth living; but also to resilience & post-traumatic growth, living more authentically after surviving a near-death experience or life-threatening illness, choosing to present oneself as survivor rather than victim. It can also mean life after death: post-mortem survival.

Social scientists, psychologists, social workers, philosophers, ethicists, theologians, political scientists, NDE researchers, all have their own understandings of and research into survival.

The 2016 CDAS annual conference will bring together research and knowledge on survival that has hitherto been fragmented.

About CDAS Conferences

CDAS conferences aim to bring together research and knowledge in ways which have not been explored before. Themes are usually set to bring together fragmented research from across a number of disciplines, highlight new and emerging research and ideas, and give a forum to researchers who often struggle to 'fit' their work into more conventional conference topics.

We encourage people at all stages of their careers and from all disciplines to attend and participate, including non-academics in relevant fields. The conference is open to everyone, not just those presenting papers, and plenty of time is set aside over the course of the weekend to allow for networking and continuation of the discussions begun in the sessions. We aim to keep the costs as low as we can so as to encourage attendance from as many people as possible.

Delegates have previously commented on the friendly and open nature of CDAS conferences, where scholars have made connections to other fields they were not previously aware of. Previous conferences have led to special journal issues, writing collaborations, new research groups and networks, and successful research funding applications.

GW4 Doctoral Student Workshop: Surviving your data

20 June 2016 University of Bath

This one day workshop will bring together doctoral students in the fields of death, dying and ageing from the GW4 network of Universities; Bath, Bristol, Cardiff and Exeter.

Skills courses on wellbeing in research often tend to focus on the research participants. This day will address the emotional impact of doing research in the areas of death and dying on the researcher. In this workshop day, practitioners, early career and senior academics will share their experiences and best practice with current doctoral students. Participants will be asked when booking to submit the 'top 3' issues they would like to see addressed, and the broad issues which are identified will be discussed during the day.

Issues already identified for possible inclusion are:

- participant confidentiality vs legal/criminal/medical/ethical responsibility
- unconscious bias
- adapting methods to the situation in front of you
- developing a researcher 'skin'
- debriefing

Please note that this workshop is **only open to doctoral students registered at a GW4 University.** We will develop a series of resources based on the day and these will be available free of charge after the event via the CDAS website.

Researchers reimagine the future cemetery at Arnos Vale

How will the dead be disposed of and remembered in years to come?

A recent design competition, organised by The Future Cemetery project, which sought to reimagine a future cemetery drawing on architectural and technological innovations has been won by international colleagues at Columbia University for a design that could revolutionise future memorialisation.

The proposal, entitled 'Sylvan Constellation' which was submitted by Columbia University's Graduate School of Architecture, Planning and Preservation, envisages a network of memorial vessels which would transform biomass into an elegant and perpetually renewing constellation of light which could illuminate pathways.

The team, based in New York, won a £5,000 prize and a month long summer 2016 residency during which they will research the historic 42-acre Arnos Vale Cemetery and work with the University of Bath's Centre for Death and Society as well as the Pervasive Media Studio at the Watershed.

The aim is to work towards a feasible design for a future prototype.

PhD studentships at The Open University

The Open University Faculty of Health and Social Care is advertising fully funded PhD studentships to start in October 2016.

Achieving good health and supporting effective social care for all is essential to achieving social justice, and this lies at the heart of the Open University's mission. Building on

existing cross-disciplinary intellectual capacity, an evidenced commitment to social justice and existing local, regional, national and international collaborations and networks, the Faculty of Health and Social Care is funding full-time PhD studentships for an October 2016 start.

Master of Public Health, University of Bradford

The University of Bradford is launching a new Master of Public Health degree (MPH). This will provide professional training in health needs assessment, epidemiology, health promotion, research methods and public health theory and policy. There are opportunities to specialise in 4 major areas within the degree - health informatics, health leadership and management, pharmaceutical services, and long-term conditions & end of life care. This is the first MPH in the UK to offer public health training in end of life care.

The course is a one-year full-time degree and does not assume prior knowledge of public health - it is a vocational graduate programme. Backgrounds in the social or biological sciences or other professional backgrounds are welcome. If you have an interest in working in palliative care policy, practice, or education and training this is a unique opportunity to re-train or re-focus your career interests and prospects.
